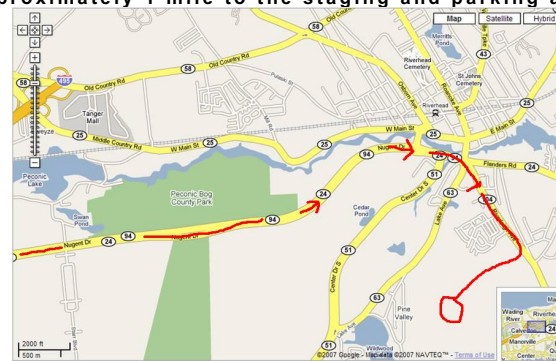

**From the Long Island Expressway eastbound, take Exit 71. Turn right at stop sign onto Nugent Drive Rt23. Travel approximately 4 miles to the Peconic Avenue Traffic Circle (immediately adjacent to the Riverhead business district), then south on County Rt 104 the 2<sup>nd</sup> right in the circle (Small Sign). Approximately 1/10 mile, south on CR 104, is the Sarnoff Preserve sign and entrance on the west (right) side. Proceed through the gate to the parking lot approximately 1 mile to the staging and parking area.**
